A funding source for In-Home Services



What is Social Services Block Grant/General Revenue (SSBG/GR)?

- SSBG is a funding source combining:
 - Federal funds allocated to states through Title XX of the Social Security Act
 - State funds appropriated by the Missouri Legislature called General Revenue (GR)
- The amount of funds available has grown increasingly smaller through the years.



Authorization

- The provider will receive a telephone call from the Division of Senior and Disability Services asking them if they can provide services to the client.
- The provider will also receive a Long Term Alternative Care System (LTACS) printout that has client information, level of care, services authorized, etc.
