

Instructions to Register with WebEx for Designated Managers Testing

IMPORTANT: Please read this entire document!

1. Click on the link to Register available on the MMAC website – **DO NOT** use your phone/device to register. **YOU MUST USE YOUR COMPUTER.**

The day will consist of a 1 hour instructor led review beginning at 9:00 am, followed by a short break, and testing immediately following.

Registration

Registration is required for each attendee prior to taking the test. Make sure that you use a valid email address, the registration email and the link to attend the online testing will be sent to and associated with the email submitted. You will also want to use a desktop or laptop for this testing session, a tablet or smartphone will not be sufficient. The registration form must be filled out completely and includes attesting that you have reviewed or will review, all of the Designated Manager training materials posted on MMAC's site prior to the classroom review & test. Space is limited. Once the training date has reached capacity, the date will no longer be available for selection on the registration form. ~~The next session will not be made available until after the current class has taken place.~~

Waiting Lists



No one will be available the day of testing to help resolve registration issues if you are not already registered or have not received the link to “Join”.

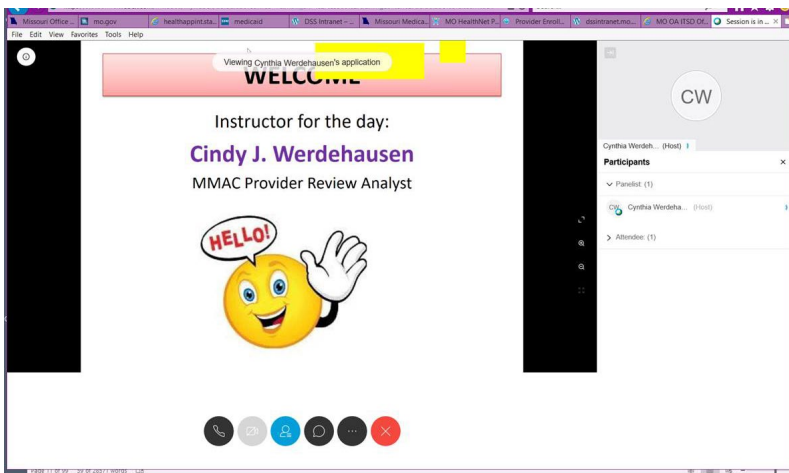
****DAY OF TESTING**** - You will receive a reminder email from messenger@WebEx.com one hour and again at 30 minutes prior to the session starting. NOTE the system will not let you join until 30 minutes prior to the start of the session. Join as soon as you can.

Important things to remember:

- **Designated Managers Test will be Open Book** - The training materials for the test should be reviewed online at MMAC’s website site prior to the class room training. **It is encouraged that you print or save the materials and familiarize yourself with them.**

- **You will need a laptop computer or desktop computer to take the test! Tablets, Chromebooks and phones are NOT allowed.**

- The test is OPEN BOOK, you will have to know how to look up regulations.
- Most of the testing material are regulations, make sure that you know how to find a regulation if given the number.
 - Ex: 13 CSR 70-91.010(4)(A)1
